Dr. Fishbein explained that Ridgewood High School would maintain the HIB file but that the file is not shared with colleges. Discipline records are usually asked of the parents by the college and it is their choice as to what is shared.

Ms. Sheer stated that Student came into her office crying because Student was continuously making racist comments (calling her Mexican). Student admitted to Ms. Sheer that he said these things and continued to say them even after Student asked him to stop.
